
The following report presents the performance to date for the first four months of the new financial year. Due to a change in staff, work is ongoing on reviewing data collection to inform this report.


At this stage of the year most activities have only recently commenced. There has been an increase in visitor numbers overall compared to the same period last year and an increase in overall merchandise sales. However the improved performance is not consistent across sites. The INNS project is drawing to a close during this period, with over 138 volunteer days contributed to date. There has been one Welsh Language complaint made in June that till receipts are not bilingual.



INNS Project - Progress	Green	Green	→	Project drawing to a close. 138 volunteer days contributed to date. Target species recorded at 120 sites. Himalayan balsam has been found at about 30 sites so far, with a total extent of 4.5 ha. Control is in progress on a total of 3.5 ha with excellent results and effective eradication a possibility by 2019. Japanese knotweed found at about 60 sites so far, with a total extent of about 9 ha. Plants were stem injected and foliar sprayed in 2015. Rhododendron has been found at about 30 sites so far, with an extent of 11 ha. 8 ha of this lies within the Trecwn Valley (Gwaun catchment) of which about a quarter has been treated. PCNPA Biodiversity Officer submitted an application for a Heritage Lottery Fund Heritage Grant development phase project in June 2016. If this application is successful, a second round application would follow in 2017 for delivery from 2018 – 2023.
